If the Purchaser appoints the Vendor's solicitors to handle the agreement for sale and purchase, mortgage and assignment, the Vendor agrees to bear the legal cost of the agreement for sale and purchase and the assignment, but the Purchaser is liable to pay the disbursements on the agreement for sale and purchase and the assignment. If the Purchaser is own solicitors to handle the agreement for sale and purchase, mortgage or assignment, each of the Vendor and Purchaser is hall pay his own solicitors (legal fees in respect of the agreement for sale and purchase and the assignment.
